TERMS AND CONDITIONS (A - THE WORLD'S FINEST CLUBS)

1. THE WORLD'S FINEST CLUBS SERVICES - The World's Finest Clubs membership allows free admission for the member and an accompanying guest into the member clubs, which have been distinguished with the Finest Clubs Award. The list of the member clubs can change at any time; the current list is available at www.finestclubs.com. At certain clubs, the member's request for entrance must be made in advance by telephone reservation. Entrance to a club cannot be guaranteed e.g., if the club is being renovated or is hosting a closed / private event. Admission to the club can be refused for improper dress or unacceptable conduct.

2. ANNUAL FEE - The fee can be paid by credit card. It is automatically debited to the club member's card at end of each membership year for the subsequent year.

3. WORLD MEMBER CARD - After the annual fee has been received, the World Member Card will be mailed to the applicant by post. The Member Card is issued annually and is for personal use only. It is non-transferable. With loss or theft of the Member Card, a replacement fee of € 50 will be charged. As soon as the Member Card expires it has to be returned to A.

4. TRAVEL, HOTELS, FOOD & DRINK, ETC. 'A' is not responsible for any additional services except those identified in clause number one. Specifically, 'A' is not responsible for any costs incurred for travel, accommodation, food and drink in connection with member events.

5. CONTRACT REVOCATION - Revocation of a new (membership) contract must be done in writing within fourteen (14) days after the original signature date.

6. CONTRACT DURATION, CANCELLATION - The contract is automatically renewed annually unless a registered letter of cancellation is received 30 days in advance of the renewal date (by postmark date). Both parties must acknowledge the cancellation in writing.

7. PERSONAL DATA - The club member is obligated to communicate change of name, address, credit card number or Email details to 'A'. The club member can choose to maintain their personal profile data on-line. The club member agrees that 'A' may share personal data with selected partners for advertising purposes.

8. EXCLUSION - 'A' reserves the right to deny member applications without explanation. Possible reasons for denial are: unacceptable behaviour in our member clubs or misuse of the personal, non-transferable Member Card.

9. CONTRACT ADJUSTMENTS - 'A' reserves the right to alter contract clauses. Any changes are communicated to the club members by Email.

10. APPLICABLE LAWS AND AREA OF JURISDICTION - The contractual relationship between 'A' and the club member are subject to Swiss law. The area of jurisdiction is Zurich, Switzerland
